their personal information. Personal information is any information that directly or indirectly identifies a user, in particular his or her name, address, ID, or email address.

Your personal data will be handled lawfully and fairly by the data controller in compliance with applicable legal requirements and in accordance with written and unwritten rules of international data protection standards. This Privacy Policy applies to the processing of personal data and is not applicable to non-natural person data. We always keep the data of our customers and partners, and we do our best, both organizational and technical, to ensure the security of the data.

The Controller reserves the right to modify this Prospectus at any time. In the event of any change in the data manager's data management, this prospectus will be modified within 30 days. The changes are codified with this information and the notice is posted on the website by the data controller.

This privacy statement describes the privacy practices of our PATI INSTRUCTOR, FORWARDER AND SERVICE BT.

Summary of your rights

How do you request information from us regarding the management of your personal information?

Upon your request, the Controller shall provide information about your personal data processed by the Controller or processed by the Controller (or processor commissioned by the Controller). Thus, their source, purpose, legal basis, duration, data processor's name, address and data processing activities, circumstances, effects and measures taken to rectify the data protection incident, as well as the legal basis and recipient of the transfer of personal data. Your information duties will be performed by the controller within 30 days of receipt of your request. You can request information in the following ways:

A request for information by letter shall be considered authentic by the controller if the request is clearly identifiable to the user. Requests for information sent by e-mail are only considered authentic by the controller if they are sent from the user's e-mail address, but this does not preclude the controller from otherwise identifying the user before providing the information. In order to comply with the request, the controller must make sure that the person who is entitled to it actually wishes to assert the rights of the data subject. This may also require, where appropriate, the personal appearance of the data subject at the data controller's office for identification purposes.

When can you ask us to correct your personal information?

If you or the Data Controller find that your personal data processed by them are inaccurate, incorrect or otherwise inappropriate, either at your request or through the Controller's own action, the Data Controller shall correct the incomplete or incorrect data.

When do you have the right to delete your personal information?

You may request the permanent and irrevocable deletion of your personal data at any time if your data is processed by your data controller with your consent. The data controller cannot delete your data if you are in the legitimate interest of the controller or in your

legitimate interest, and in complying with the statutory storage and retention obligations. The Data Controller shall delete the personal data at the same time as the purpose of data processing ceases. The controller also deletes the data if it is proved that the processing of the data is unlawful for some reason, or if its deletion is ordered by a public authority or a court.

When do we need to lock your personal information?

You may at any time request the processing of some or all of the data you provide to the Controller. In the case of a request for the deletion of the data, the controller will not erase it, but will block the data if deletion would harm your legitimate interest. Locked data will be handled by the data controller only for as long as the reason for the lock exists, after which the locked data will also be deleted.

How do you withdraw your consent to the management of your personal information?

You have the right at any time to withdraw your consent to the processing of your personal data. Revocation of consent sent by letter shall be deemed by the controller to be authentic if the request is clearly identifiable to the user. Revocation consent sent by e-mail is considered authentic by the Controller only if it is sent from the user's e-mail address, however, this does not preclude the Controller from otherwise identifying the User prior to providing the information.

How can I go to court if we have violated our rights?

You have the right to go to court in connection with your data management. You may also lodge your claim against the controller with the competent court of your choice in the court of your place of residence. Your application will be examined by the court in an out-of-court procedure.

How do we get your personal information ?

You provide your personal information to the controller. If the data have not been received from you, the Controller shall, upon discovery or upon your request, promptly delete at its request the illegally submitted form together with its full data content.

What do we do to keep your personal information secure?

The Data Controller shall use all reasonable means and technical means at its disposal to ensure the security of the data and shall take all necessary steps to this end, including strictly restricting access to the data.
